Disability History Week Passed in State Legislature

The recently completed session of the State Legislature saw New York State officially recognize the history of people with disabilities. By unanimous votes in both the Assembly and the Senate, New York State will recognize the third week in October as New York State Disability History week. The resolution, introduced by Assemblymember Mark J.F. Schroeder at the request of People Inc.'s Museum of disABILITY History states: "it is desirable that state post-secondary institutions promote activities that provide education, awareness, and understanding regarding people with disabilities, and the disability rights movement, through school curriculum, school assemblies and other school activities."

The progress of State Legislative activity surrounding the establishment of a Disability History Week/Month has been tracked since the signing of West Virginia's House Bill 4491 on April 3, 2006. Florida and North Carolina are close to having a bill passed. Other states are also moving forward in the form of a bill or request to ask their governor to memorialize – as New York State did. Among them are Connecticut, Pennsylvania, North Carolina, Iowa, Michigan Washington, Idaho, and Kentucky.

Museum's New Website Receives Critical Acclaim

Take a look at disability history by visiting the Museum of disABILITY History's new website, www.museumofdisability.org, which was launched to critical acclaim in October 2006. In less than six months, this new website has won rave reviews from viewers, has won at least one award for outstanding achievement, and has had over 1.25 million hits from 40,000 visitors from over 100 different countries. The new website was funded in part by a generous grant given by the B. Thomas Golisano Foundation. Recent additional grant support for the website has been received from the Institute of Museum and Library Service's "Museums for America" program and the New York State Office of Mental Retardation and Developmental Disabilities.



The Museum of disABILITY History's new virtual website is a unique foray into disability history. Check it out at www.museumofdisability.org.

The three main wings of the virtual museum are the *Medicine, Media* and *Society* wings. The *Medicine* wing contains a medical timeline spanning over 2,000 years of disability related events and people, as well as exhibits on cures, prevention, and the medical establishment. The *Media* wing includes a timeline of disability and the media, and an extensive bibliography of professional literature. The *Society* wing contains the largest number of exhibits including advocacy, educators, education, sports, Kennedy family advocacy, and eugenics. This wing also includes an interactive map of New York State institutions providing a brief history of each institution and concisely narrating

The Museum of disABILITY, its new website and the disability week designation are charting a course for all of us!

In hen you read this issue of People To People, you will notice a reoccurring theme of the success we have had in recent months regarding the Museum of disABILITY History. The history of people with developmental disabilities must be told to the general public.

We have made it a priority at People Inc. - as have others - to make sure people are informed and educated on this important topic.

Golisano Grant

In 2004, we received a grant from the B. Thomas Golisano Foundation to create a virtual website that depicts the history of people with disabilities. This state-of-the-art website will be considerably expanded upon and enhanced due to another significant grant award by the Golisano Foundation this spring.

New York State Disability History Week and Federal Recognition

In addition to the website enhancements, the recent award from the Golisano Foundation charges us to develop a curriculum that will be used in school districts throughout the state as part of the creation of New York State Disability History Week. In the recent session of the New York State Legislature, Assemblymember Mark J.F. Schroeder proposed the creation of this special designation. Our curriculum will be the foundation of the New York State Disability History Week, and will be available online through our virtual museum at **www.museumofdisability.org**. We are grateful to Mr. Schroeder and his colleagues for recognizing the importance of the history of individuals with disabilities.

Last year, I was appointed a member of President Bush's President's Committee for People with Intellectual Disabilities. This is the longest standing Presidential committee, originally created by John F. Kennedy in 1961. At our most recent meeting, the committee and I voted to recommend to the President, the creation of a federal disability history week.

Whether it is working collaboratively with the B. Thomas Golisano Foundation or our elected leaders, we have made it a priority to do what we can to educate and inform the general public. Everyone in some way or another is touched by someone with a disability. It's our goal to let people know the past while stressing the accomplishments that have been made.

These efforts are important. We need to educate people about this history. We see it as an evolution of our mission - integrating people with disabilities into the community, and creating a more accepting community. We want everyone to understand, and appreciate them, and consider their role in creating a better future.

Similar to the way Black History is taught in schools now, the path to a state/federal disability history week will evolve and grow. We are in our infancy. The first Black History Week was commemorated in 1926 - look what it has become. We are excited about the future. The Museum of disABILITY History, its new website, and the disability history week designation are charting a course for all of us. Watch for more information as these projects unfold and come to fruition.

Consumer Directed Personal Assistance Program Promotes Independence, Flexibility, and Choice

o you or a loved one need in-home care with a dedicated provider? The Consumer Directed Personal Assistance Program was designed to enable an individual to have more control over their own in-home care. Those who participate in the program find that they have increased flexibility with scheduling and dedicated staff. The individual takes a more active role in recruiting, interviewing, and supervising the attendants of their choice who meet the hiring qualifications. The individual and the attendant work together to create a schedule that meets specific home care needs.

Qualifications for the program include: must be a resident of Erie or Niagara County; be eligible for Medicaid and to receive home care services; and must be willing to participate in a training program that will review recruitment, hiring, training, and problem solving.

Director of Home Care Services Susan Benedict-Bayerl states, "The greatest benefits of this program are that the individual is able to remain in their home and have freedom of choice over their home care services."

The Museum of disABILITY History is offering free performances of its educational puppet program, the Kids on the Block. The program is part of People Inc.'s community outreach initiative promoting awareness, education, and acceptance of individuals with disabilities. The environment created through the medium of puppetry allows children to feel comfortable asking questions directly to the puppets. The question and answer periods provide an opportunity for the puppeteers to dispel some of the myths and misconceptions children often have about disabilities and those who are "differently-abled." A student named Mia recently saw a performance and shared, "I think people should pay extra attention to learn about people with disabilities. You taught me a lot."

"Yesterday at Batavia Rotary I saw an excellent presentation by two staff from "Kids on the Block." This is a program on disabilities awareness for school kids, using puppet theater techniques. It was engaging, very professionally done, obviously based on much experience and research by caring people, and really made the point"

The website offers an educational resource to employees within the field of developmental disabilities, to individuals with disabling conditions and their family members, and to students, scholars, and other researchers. Since its launch, the Museum of disABILITY History has received numerous requests for additional information, for permission to use images in the Museum's collections for exhibits at other institutions, and for use in articles, books, and television productions. At the same time, the Museum's staff continue to research and develop topics that will allow for expansion of our virtual exhibits and resource materials. The ultimate goal of the Museum's website is the expansion of worldwide community awareness regarding people with disabilities and their impact on society. GIFTS TO PEOPLE INC.: BEQUESTS

A bequest is simply a gift arranged now (in your will), that is made later. A bequest made for the benefit of People Inc. can be included in the body of your will, or through a codicil (an amendment to your will), or your revocable trust.

To name People Inc. as the beneficiary, you should use the legal name "People Inc." or "People Inc. Foundation" (not People Incorporated). Several types of bequests are available, and you should choose the type that best suits your personal objectives.

For example, your bequest can be a stated dollar amount, or you can leave specific property to the agency. Some of our friends prefer to bequeath a certain percentage of their estate (the amount that remains after paying all debts, costs, and other prior legacies).

Whichever type you prefer, you can direct that your bequest be used for the current needs of People Inc., or for a specific purpose within our mission.

If you wish, you can indicate that your bequest is to be added to one of People Inc. Foundation's endowment funds. A bequest of \$10,000 will allow us to establish an endowed fund in your name or in the name of whomever you wish to honor.

Whatever your objectives, we will be happy to work with you in planning a bequest that will be satisfying, economical and effective in carrying out our important mission into the future.
